A federal judge has <u>halted the Trump administration's plans to roll back the Deferred</u> <u>Action for Childhood Arrivals (DACA) program</u> for now, but the president's position is unclear after yesterday's <u>confusing meeting with lawmakers</u>. Columnist Fr. Tom Reese reminds Christians that <u>baby Jesus was a Dreamer</u> in Egypt, while Pope Francis warned global leaders to <u>stop stirring up fear when talking about immigrants</u> <u>and refugees</u>.

In other legal news, a court has struck down North Carolina's Republican gerrymandered congressional map.
